



50/50 RAFFLE RULES Terms and Conditions

By participating in the United Way of Northern New York's (UWNNY) 50/50 Raffle (the "Raffle"), participants agree to be bound by these Terms and Conditions. The Raffle is a fundraiser to support the charitable efforts of UWNNY and by participating in the Raffle, entrants acknowledge, understand and agree that their participation in the Raffle is voluntary.

1. **Sponsor.** The Raffle is sponsored by UWNNY, a New York State nonprofit organization. All decisions made by the Sponsor, with respect to the Raffle, are final.
2. **Eligibility.** The Raffle is open to legal residents of the New York State, United States, who are physically located in the New York State, United States, 18 years of age or older as of July 1, 2021. UWNNY Board Members and Officers and their immediate families are not eligible to enter to participate in the Raffle.
3. **How to Enter.** Raffle tickets are available for purchase in-person at UWNNY with the physical address of 120 Washington Street, Suite 201, Watertown, NY 13601; from any UWNNY employee; and online at www.unitedway-nny.org/truck-pull. If entering the Raffle online, the purchaser will be sent a receipt via e-mail that will identify the purchaser's unique raffle ticket number(s). U.S. Postal regulations prohibit the mailing of raffle tickets.
4. **Cost.** The purchase price of each ticket costs \$10.00 for one ticket and \$25.00 for three tickets and is non-refundable. Each ticket is one chance to win the raffle prize. Participants may purchase as many tickets as desired.
5. **Raffle Period.** The Raffle period shall take place from the date the first ticket is sold on July 12, 2021 through October 2, 2021.
6. **Transferability.** A transfer of a raffle ticket constitutes a waiver of the right to claim the prize.
7. **Drawing.** The drawing will be held at UWNNY's office on Sunday, October 3, 2021.
8. **Prize.** The prize awarded will be 50% of the all the revenue generated by Raffle ticket sales.
9. **Affidavit of Eligibility.** The winner of the Raffle shall be required to provide UWNNY with a signed statement, attesting to the winner's eligibility, compliance with the terms, and permission for UWNNY to use the winner's name, city, state, voice, and likeness in media releases and other publicity.

10. **Notification.** The holder of the winning ticket shall be notified by telephone and/or e-mail and Certified U.S. Mail at the address provided by the participant. The winner does not need to be present at the drawing to win.
11. **Taxes.** All applicable federal, state, and local tax; registration; and delivery fees associated with winning the prize in the Raffle will be the sole responsibility of the winner. The winner shall be provided a 1099 form for income tax purposes.
12. **Amendments.** UWNNY reserves the right to amend the terms, conditions, and procedures of the Raffle at any time.
13. **Release of Liability.** Participants release UWNNY and its directors, officers, members and agents from any and all liability, loss or claim arising out of any raffle prize, and expressly waive any such claim and agree that the liability, if any, of UWNNY and its directors, officers, members and agents shall be limited to the price of the Raffle ticket.
14. **Governing Law and Venue.** Terms and conditions shall be governed by and construed in accordance with the laws of New York State. Any disputes relating to the Raffle must be held in courts of competent jurisdiction in Jefferson County, New York.
